Minutes Of The Technical Bids Evaluation Committee Meeting Held On 21-04-2026 In The Chamber Of Chief Engineer, National Highways, Bangalore.

Name of the Work : Package-01

1. Providing permanent restoration to earth slips by Grouted Anchors, Soil Nailing and Shotcrete at km 239.400 RHS & km 249.700 LHS (at 2 locations on shiradi ghat) of NH-75 B.C road Vellore section.
2. Providing permanent restoration to earth slips by Grouted Anchors, Soil Nailing and Shotcrete at km 239.850 LHS (shiradi ghat) of NH-75 B.C road Vellore section.
3. Providing permanent restoration to earth slips by Grouted Anchors, Soil Nailing and Shotcrete at km 240.050 RHS & 241.500 RHS (2 locations on shiradi ghat) of NH-75 B.C road Vellore section
4. Providing permanent restoration to earth slips by Grouted Anchors, Soil Nailing and Shotcrete at km 241.550 RHS, km 241.700 RHS, km 241.900 RHS & km 242.200 RHS (4 locations on shiradi ghat) of NH-75 B.C road Vellore section.

Preamble

The Government of Karnataka, vide Official Memorandum No: ಕಂ.ಇ/20/ಟಿ.ಎಸ್.ವೈ/2025(ಭಾ-1) Dated:20-11-2025 has accorded Administrative approval for total 10 Number of works amounting to Rs. 31.21 Crs pertaining to NH Division Hassan. The aforesaid works are included in the Approved Programme of works under State Disaster Management Fund(SDMF) by Revenue Department, GOK vide SI No 1,2,3 & 4 for estimate cost of Rs 3.60 Crs, 2.55 Crs, 4.23 Crs & 4.86 Crs respectively. The same was communicated by the Deputy Commissioner, Hassan vide letter No:CAL/01/2025-26 Dated:11-12-2025.

Technical Sanction for above mentioned 4 Nos of works have been accorded by the Chief Engineer, National Highways, Bengaluru on 28.01.2026 as tabulated below.

Accordingly, the Executive Engineer, National Highways Division, Hassan has opened the received bids for the instant package on 23.03.2026. No bidders have participated for the said work.

Further, permission has been sought to invite a Re-tender by limiting the tender period to 7 days for the above mentioned work, vide the Executive Engineer, National Highways Division, Hassan letter No:EE/NHD/HSN/AE-1/SDMF/PACKAGE-1/Short Term/ 2025-26/1761 dated:26.03.2026.

The Short Term Tender time period i.e. 7 working days is approved as stipulated in the KTPP Rules 2000, rule 17, Sub-Rule 1&2 vide the Superintending Engineer ,National Highways Circle, Bengaluru letter no: SE/NHC/BNG/TA/JE-2/SDMF/PKG-1/Short term tender/2025-26/3123-124 dated:26.03.2026.

Therefore, Tenders for the above work has been invited as a Package work vide Executive Engineer, National Highways Division, Hassan office

Accordingly, the Executive Engineer, National Highways Division, Hassan has opened the received bids for the instant package on 08.04.2026 and reported that the below mentioned only Four(4) bidder had participated, i.e,

All bidders have submitted the original copies of EMD (BG/FDR), DD and LOC except **J V Manjunath Reddy** within the stipulated date and time of opening of tender as specified in the Notice Inviting tender. Bidder's documents of 3 bidders 1) **M/s AECS Engineering & Geotechnical Services Private Limited, Noida.** 2) **UNIQUE PRISM.** And 3) **M/s H M B S Textiles Private Limited** were downloaded and considered for evaluation and submitted for approval through proper channel.

Hence, the meeting of the Technical Bid Evaluation comprising the following members is convened on 21.04.2026 in the chambers of the CE, N.H, Bangalore, to evaluate the technical bids received for the above said work.

M/s H M B S Textiles Private Limited

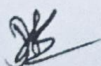
The agency has uploaded the required Bid security, Bid capacity, and turnover for 5 years, original EMD submitted on time but the Scaffolding material with platforms at top for placing Drilling Rigs is not available uploaded document submitted by the agency and the bidder does not fulfil the criteria of the Quantities executed in any one Financial years, out of last five years. Hence, As per Qualification criteria of the tenderer, the Technical Bid of the bidder is considered as non-responsive.

COMMITTEE CONCLUSION:-

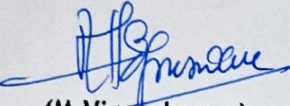
