

Minutes of the meeting of the Evaluation Committee held on 09.06.2026 for Evaluation of Financial bids for the work of "Short term Maintenance Contract for 36.60 Km from Km 0.900 to km 27.500 and km 29.500 to km 39.500 of NH-131A under N.H. Division No. VII, P. W. (Roads) Directorate in The Districts of Malda during the year 2025-2026.

(Job No. NH-131A/WB/2025-26/STMC-13), Tender ID: 2026_MoRTH_901746_1].

1. 1st Meeting for Evaluation of Technical Bids for the above-mentioned work was held on 18.05.2026, where out of 05(five) participants, 03(three) bidders were declared Responsive namely:

- (i) Millenium road Construction Pvt. Ltd.
- (ii) Roads (India) International
- (iii) C.R. Sen.

SE, NH Circle-III informed that the Technical bid evaluation summary containing the name of technically responsive and non-responsive bidders with due reasons was uploaded on the e-tendering portal <http://eprocure.gov.in/eprocure/app> on dated 21.05.2026 with a intimation that the financial bid of the responsive bidders will be opened on 25.05.2026 by 14:00 Hrs.

2. The Superintending Engineer, NH Circle-III informed the members of the Evaluation Committee that 05 (five) representations received regarding the results of Technical Evaluation before opening of financial bids.
3. Considering the significance of the above, 2nd Meeting of the Evaluation Committee was conducted to evaluate all 05 (five) Technical Bids on 04.06.2026. After a detailed discussion on different aspects and in accordance to the guidelines for evaluation of Technical bids published by MORT&H, following 04(four) bidders were considered "Technically Responsive and qualified bidders" namely:

- (i) Millenium road Construction Pvt. Ltd.
- (ii) Roads (India) International
- (iii) C.R. Sen.
- (iv) M.C. Enterprise

4. After observing and fulfillment of all criterion as per recommendation of the Technical Evaluation Committee through its Minutes of the 2nd Meeting on 04.06.2026, necessary steps towards revocation of tender was taken up to publish the revised list of 04(four) nos of "Technically Responsive and qualified bidders" through the e-tendering portal. Financial Bids of the above 4(four) Responsive bidders were opened (online) through the e-tendering portal on 08.06.2026. Details of the Financial Bids are as below:

5. On examining the Financial Bids of the bidders, Evaluation Committee observed that the rate Quoted by "M.C. Enterprise" for an amount of Rs. 42399904.65 (Rupees Four Crore Twenty Three Lakh Ninety Nine Thousand Nine Hundred Four and Paisa Sixty Five) only, including 18.00% GST stood lowest.
6. After a detailed discussion on the bidders, Evaluation Committee recommends the Lowest Bidder "M.C. Enterprise" of Balurghat, Dakshin Dinajpur, with a Quoted Bid Price of Rs. 42399904.65 (Rupees Four Crore Twenty Three Lakh Ninety Nine Thousand Nine Hundred Four and Paisa Sixty Five) only including 18.00% GST to award the work.
