1. SE, N.H. Circle No.III informed that, Administrative Approval with Financial Sanction, and Technical Sanction was accorded by the Ministry vide letter no. NH-15017/30/2024- P & M, Dt- 19.02.2026 and NH-12014/23/2026-RO-KOL dated 26.02.2026 for the above mentioned STMC work.
2. In light of approval of the work, on-line bid was invited by the Sr. Superintending Engineer, N.H. Circle No.III, P.W. (Roads) Directorate, on behalf of Chief Engineer, NH Wing through the e-tendering portal <https://eprocure.gov.in/eprocure/app> for the subject work under e-RFP No.13 of 2025-26 of Sr. Superintending Engineer, NH Circle-III dated 26.02.2026 under single stage two cover system. After receiving of the Bid Security and other original bid documents physically within due date and time, Technical Bid was opened from the web portal: <https://eprocure.gov.in/eprocure/app> on 29.04.2024 after 14:00 hrs in the office of the Sr. SE, NH Circle-III, Siliguri, and it was found that following 5(Five) bidders have participated in the bid namely:
 - (i) C.R. SEN
 - (ii) M. C. ENTERPRISE
 - (iii) Millenium road Construction Pvt. Ltd.
 - (iv) MS RATAN ENGINEERING CO
 - (v) Roads(India) International
3. All the technical bids received from the 5(Five) bidders have been scrutinized by the Evaluation Committee in accordance with the qualification criteria and Terms & Conditions of the RFP to substantiate Credential in respect of (i) Executed of work [Cl. 4.3A(b)] (ii) Bid Capacity [Cl. 4.4] (iii) Av. Annual Turnover for last 3 years i.e. 2022-23 to 2024-25 [Cl. 4.5.3] of the RFP, and other criteria.
4. As a first step towards evaluation of the Technical Bids, Sr. SE, NH Circle-III has determined the responsiveness of the Technical Bid to the requirements of RFP as per provision under Cl. 23 of ITB of the RFP issued vide Ministry's letter no. RW/NH-37010/4/2010-EAP(Printing) Vol. IV, dated 05.03.2019 and submitted the detailed evaluation sheet before the Evaluation Committee. The detailed evaluation sheet as per the RFP is placed at Annexure-I.
5. Thus the proposals of the bidder has further been evaluated by the concerned SE, NH Circle III based on the requisite documents furnished to substantiate the Threshold Technical Capacity in accordance to Clauses 16 for Bid Security, 4.3A, Mandatory Technical Experience from the Eligible Projects in Category 1 and / or Category 3 specified in accordance to Clause 4.3b, Financial Capacity in accordance to clauses 4.3 (a) of the RFP respectively and Bid Capacity in accordance to Clause no. 4.4 of the RFP.

During verification of the documents submitted by the bidders it is noticed that the Bid Security submitted by 2(two) no of bidders namely: i) M. C. ENTERPRISE and ii) MS RATAN ENGINEERING CO, are valid for 3(three) month only.

Whereas as per Clause 16 of the RFP it was notified that validity of bid security should be "180 (one hundred eighty) days from the BID Due Date, inclusive of a claim period of 60 (sixty) days".

In respect of Credentials, M.C Enterprise has submitted 2(two) no. of works of relevant credetials, however the ist work value executed is less than the minimum value required for singhl work, and Financial progress for the 2nd work has not been mentioned therein.

Credential submitted by MS Ratan Engineering Co. is not of similar nature of works.

7. On further discussion following 3 (Three) Bidders were declared as "Responsive & Technically Qualified" bidders: -
- i) C.R.SEN
 - ii) Millenium road Construction Pvt. Ltd
 - iii) Roads(India) International
8. In view of the above, the Evaluation Committee recommends opening of Financial Bid of the above "Responsive & Technically Qualified" bidders at the earliest after online publication of results of technical evaluation. However the technically qualified bidder may be requested to submit the updated value of Bid Capacity, if any, before opening of financial bids as per clause 23 of the RFP.

1. SE, N.H. Circle No.III informed that, on receipt of Administrative Approval with Financial Sanction, from the Ministry vide letter no. NH-15017/30/2024- P&M, Dt-19.02.2026(sl-3) and Technical Sanction vide NH-12014/22/2026-RO-KOL dated 26.02.2026 for the above mentioned STMC work, on-line bid was invited through e-tendering portal: <https://eprocure.gov.in/eprocure/app> for the subject work vide e-RFP No.14 of 2025-26 of Sr. Superintending Engineer, NH Circle-III, dated 26.02.2026 under single stage two cover system.
2. Technical Bid was opened from the web portal: <https://eprocure.gov.in/eprocure/app> on 29.04.2024 after 14:00 hrs in the office of the Sr. SE, NH Circle-III, Siliguri, and following 5(Five) bidders participated in the bid namely:
 - (i) C.R. SEN
 - (ii) M. C. ENTERPRISE
 - (iii) Millenium road Construction Pvt. Ltd.
 - (iv) MS RATAN ENGINEERING CO
 - (v) Roads(India) International
3. During 1st Meeting of the technical Evaluation Committee held on 18.05.2026, the technical bids received from all 5(Five) bidders were scrutinized in accordance with the qualification criteria and Terms & Conditions of the RFP to substantiate Credential in respect of (i) Executed of work [Cl. 4.3A(b)] (ii) Bid Capacity [Cl. 4.4] (iii) Av. Annual Turnover for last 3 years i.e. 2022-23 to 2024-25 [Cl. 4.5.3] of the RFP, and other criteria.
4. During verification of the documents submitted by the bidders it was noticed that the Bid Security submitted by 2(two) no of bidders namely: i) M. C. ENTERPRISE and ii) MS RATAN ENGINEERING CO, are valid for 3(three) month only.

Whereas as per Clause 16 of the RFP it was notified that, validity of bid security should be "180 (one hundred eighty) days from the BID Due Date, inclusive of a claim period of 60 (sixty) days".

In respect of Credentials, i) M.C Enterprise has submitted 2(two) no. of works as relevant credentials, however the 1st work value executed is less than the minimum value required for single work, and Financial progress for the 2nd work has not been mentioned therein. ii) Credential submitted by MS Ratan Engineering Co. is not of similar nature of works.

5. Based on the detailed evaluation, the Evaluation Committee recommends the following 2 (two) bidders as "Non-Responsive" bidders, namely:

- i) M. C. ENTERPRISE and
- ii) MS RATAN ENGINEERING CO.

Following 3 (Three) Bidders were declared as "Responsive & Technically Qualified" bidders: -

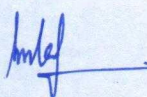
- i) C.R.SEN
- ii) Millenium road Construction Pvt. Ltd
- iii) Roads(India) International

6. Based on the recommendation of the Evaluation Committee in the 1st Meeting Sr. SE NH Circle-III, published the name of Responsive and Non-Responsive bidders online, and declared the schedule date of opening of Financial bid of the above Responsive & Technically Qualified bidders on 25.05.2026.

7. Following objections have been received from bidders in the mean time:

- a. MC Enterprise on 22.05.2026, 23.05.2026, 25.05.2026, 27.05.2026 and on 31.05.2026 regarding their representation to consider their bid as responsive.
- b. M/S Ratan Engineering Co. on 03.06.2026 regarding consideration of their bid as responsive.

- c. Road (India) International, dated 04.06.2026 for not reconsidering the bid by MC Enterprises as it was earlier rejected by tender evaluation committee.
- d. Millenium Road Construction Pvt Ltd dated 04.06.2026 for not reconsidering the bid by MC Enterprises as it was earlier rejected by tender evaluation committee.
- e. C R Sen dated 04.06.2026 regarding adherence to RFP terms and evaluation integrity.
8. The aforesaid objection letters from bidders were placed to the Evaluation Committee. After due consideration of the contents of objections received from bidders and after detailed discussion on the matter vis a vis tender stipulations, Broad findings of evaluation at the 2nd Meeting is as follows:
9. In respect of bidder M C Enterprise - M C Enterprises had earlier submitted valid bank draft as Bid Security with validity of 3-months. The provision exists in Tender RFP for submission of Demand Draft as bid security (Cl- 9 of NIT) and now concern bank has intimated that the same can be extended for a period of another 3- month on request of bidder/authority. So bid security submitted may be treated as valid document. In regards to credential, the bidder's contention that the physical and financial progress match with each other and work has already completed hence may be accepted.
10. In respect of M/S Ratan Engineering Co -- The committee deliberated that his bank Draft submitted earlier as bid security may be treated as valid but his credential submitted is not of similar nature of work, so his request for considering his bid as responsive may not be entertained.
11. The objection by Millenium Road Construction Pvt. Ltd, Roads (India) International & C R Sen, regarding their contention for not reconsidering the bid of MC Enterprises and adherence to RFP terms and evaluation integrity is rejected, as the tender Evaluation Committee in conformity of clause 23.5, of ITB Section - II, E of RFP, can consider the objection by the bidder and can act accordingly and there is no question of violating RFP terms and evaluation integrity.
12. Based on the detailed evaluation, the Evaluation Committee recommends the following 1 (One) bidders as "Non-Responsive" bidders, namely:
- i) MS Ratan Engineering Co.
- Following 4 (Four) Bidders are now declared as "Responsive & Technically Qualified" bidders namely:
- i) C.R.SEN
ii) Millenium Road Construction Pvt. Ltd
iii) Roads(India) International
iv) M.C. Enterprise.
13. In view of the above, the Evaluation Committee recommends revocation of technical bid and now to qualify above named bidder as responsive. The Committee requested Sr. Superintending Engineer, NH Circle- III for opening of Financial Bid of the above "Responsive & Technically Qualified" bidders at the earliest after online publication of results of technical evaluation.

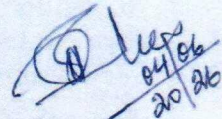

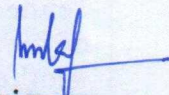
