2. At the outset, the Chief Engineer (NH) & Addl. Secy. welcomed the participants. The Committee was apprised that the technical, administrative and financial sanction to the instant work amounting to Rs. 37.38 Crore.

3. EE (NH) Division Gandhidham apprised that the civil cost of the work is Rs. 29.43 Cr. Bid was invited by the State Government through e-bidding on CPPP portal of the Ministry. The last date for receipt of bids was 27.03.2026 and bids were opened on 30.03.2026. The details of the bidders submitted their bids for the work are as under:

4. The Committee observed that above all bidders qualify preliminary criteria such as submission of Declaration, tender fee, And Power of attorney etc.

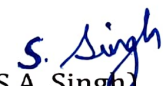
5. The Technical Bid of all four (4) bidders are evaluated on 06 /04/2026 by the Committee and the 3(Three) bidders were found technical responsive by the committee. M/s. ABS CONSTRUCTION CO was found non-responsive due to submission of insurance surety bond as Bid Security in place of Bank Guarantee. M/s. ABS CONSTRUCTION CO has submitted representation on 06.04.2026 mentioning that the insurance surety bond has been submitted as Bid Security as per MORT&H circular dated on 31.05.2023. Hence, the committee has considered M/s. ABS CONSTRUCTION CO responsive. Accordingly, revised responsiveness status of bidders are as following:

6. The Evaluation committee recommended for opening of financial bids of above four (4) technically responsive.

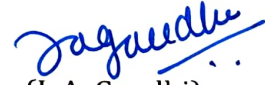
