

**MINUTES OF FINANCIAL BID EVALUATION COMMITTEE MEETING HELD ON 14.07.2026 AT 15:00 PM
IN THE OFFICE OF THE REGIONAL OFFICE, MORT&H, ASSAM, CHANDMARI, GUWAHATI-03.**

Name of Work: "Urgent Restoration of waterlogged stretch at Km 17/900 (in front of Hajo Revenue Circle Office) of NH-427 with GSB, WMM and Interlocking Concrete Block Pavement under PWD, Guwahati NH Division in the State of Assam. (Under Contingency Provision of Job No. 427/AS/2022-23/245)

Bid Value: Rs 44,34,159.00 /- (Excluding GST & including 1% Labour cess)

Based on the recommendation of the Bid Evaluation Committee in the minutes of technical bid evaluation meeting held on 06.07.2026, the financial bids of following 2 (Two) technically responsive bidder were opened on 14.07.2026 at 15:00 PM in the O/o the Regional Officer, MoRT&H, Guwahati, in presence of the Bid Evaluation Committee (BEC) members. The summary of the financial bids opened is as follows:

The committee recommends that the work may be awarded to the bidder- M/s Prakalpa, Sweet Apartment 3rd Floor, Guwahati-781021 at their lowest quoted bid price of Rs.36,74,000.00 (Rupees Thirty Six Lakh Seventy Four Thousand Only) which is 17.14% below the amount put to tender Rs.44,34,159.00. In keeping with provision of clause 34.1 of Instructions to Bidders of the bidding document the BEC has recommended that the bidder must provide a performance security of 3 % (Three percent) of the amount quoted by the bidder i.e. 3% of Rs. 36,74,000.00 = Rs. 1,10,220 (Rupees One Lakh Ten Thousand Two Hundred and Twenty only). Additionally, the bidder is required to furnish an additional performance security along with the performance security of 3% (three percent). The calculation for the additional performance security for the unbalanced bid is determined as per Clause 34.2.1 of RFP which comes out to be 0.70% (Zero point Seven Zero percent). Therefore, the additional performance security that shall be obtained from the L1 bidder is found to be 0.70% of bid price, which is Rs.25,718.00 (Rupees Twenty five Thousand Seven Hundred and Eighteen only).



In view of the above, the Bid Evaluation Committee (BEC) decided that, the work shall be awarded to the L1 bidder subject to approval of the Additional Performance Security for the bidder from the Competent Authority in accordance with MoRT&H's latest circular no. RW/NH-33044/34/2024-S&R (P&B) (Computer no. 246283) dated 30.04.2025 and subsequent amendments.

The item wise rates quoted by the technically responsive bidder considered for financial evaluation is depicted in the Comparative Statement attached herewith.
