

Minutes for Evaluation of Technical Bids held on 06.07.2026 in the Office of Regional Office,
MoRT&H, Assam, Chandmari, Guwahati-03 through VC.

Name of work: Urgent Restoration of waterlogged stretch at Km 17/900 (in front of Hajo Revenue Circle Office) of NH-427 with GSB, WMM and Interlocking Concrete Block Pavement under PWD, Guwahati NH Division in the State of Assam. (Under Contingency Provision of Job No. 427/AS/2022-23/245)

A. Reference of according sanction to the project:

- i) Sanctioned amount of Estimate: Rs. 52.32 lakhs.

B. Bidding Process:

(i) Bid Value: Rs. 44,34,159/- (Excluding GST & including 1% Labour cess)

(ii) The bids for the above-mentioned work were invited vide IFB No. NHR.09/2026/2 dated 04.06.2026 and the bidding documents were made available in the MoRT&H e-tendering portal "<https://eprocure.gov.in/eprocure/app>" from 05.06.2026 (from 14.00 Hrs.) to 25.06.2026 (upto 14.00 Hrs.). The Pre-bid meeting was held on 12.06.2026 from 12.00 hrs. to 14.00 hrs. as per schedule. No bidder attended the meeting. The Technical Bids were opened online on 26.06.2026 at 14.00 hrs. in the O/o of Regional Officer, MoRTH, Guwahati as per Ministry's OM dated 22.06.2026, in presence of Bid Evaluation Committee Members from <https://eprocure.gov.in/eprocure/app> & in presence of bidders/ representatives of bidders.

(iii) The following 3 (three) bidders has submitted bid for the above-mentioned work -

C. Evaluation of Technical Bids:

To establish the responsiveness of each & every individual technical bid, the qualification information submitted online by the bidder has been examined on the basis of technical qualification criteria laid down in the bidding documents and compiled in the form of a statement - "TABLE FOR EVALUATION OF SUBSTANTIVE RESPONSIVENESS OF TECHNICAL BIDS" to be placed before the Bid Evaluation Committee.

The meeting of Bid Evaluation Committee (BEC) for technical evaluation of bids was held on 06.07.2026 at the O/o of Regional Officer, MoRTH, Guwahati in presence of Regional Officer, MoRTH as Chairman of Bid Evaluation Committee (BEC) along with other members of BEC. The Bid Evaluation Committee verified and examined the documents of the technical bids & all other relevant papers. The deliberations of the Bid evaluation committee are as follows:-







1. M/s Prkalpa.: Qualification information submitted by the bidder is found to be in order as per stipulations of RFP.
2. M/s Abdur Rekib.: Qualification information submitted by the bidder is found to be in order as per stipulations of RFP.
3. M/s Samia Construction: Upon examination of the bid documents, it has been observed that the bidder does not have any similar work and satisfy the minimum eligibility criteria prescribed under Clause 4.5.3(b)(i) of the RFP. Therefore, the bidder is treated as non-responsive.
