

Minutes for Evaluation of Technical Bids held on 06.07.2026 in the Office of Regional Office, MoRT&H, Assam, Chandmari, Guwahati-03 through VC.

**Name of work:** Urgent Restoration of waterlogged stretch at Km 16/920 (in front of Amuthi Dhaba, Abhaypur) of NH-427 with GSB, WMM and Interlocking Concrete Block Pavement under PWD, Guwahati NH Division in the State of Assam. (Under Contingency Provision of Job No. PBMC/15/AS/2023-24/250).

A. Reference of according sanction to the project:

i) Sanctioned amount of Estimate: Rs. 23.97 lakhs.

B. Bidding Process:

(i) Bid Value: Rs. 20,31,531/- (Excluding GST & including 1% Labour cess)

(ii) The bids for the above-mentioned work were invited vide IFB No. NHR 13/2026/2 dated 08.06.2026 and the bidding documents were made available in the MoRT&H e-tendering portal "<https://eprocure.gov.in/eprocure/app>" from 09.06.2026 (from 14.00 Hrs.) to 29.06.2026 (upto 14.00 Hrs.). The Pre-bid meeting was held on 15.06.2026 from 12.00 hrs. to 14.00 hrs. as per schedule. No bidder attended the meeting. The Technical Bids were opened online on 30.06.2026 at 14.00 hrs. in the O/o of Regional Officer, MoRTH, Guwahati as per Ministry's OM dated 22.06.2026, in presence of Bid Evaluation Committee Members from <https://eprocure.gov.in/eprocure/app> & in presence of bidders/ representatives of bidders.

(iii) The following 1 (one) bidders has submitted bid for the above-mentioned work -

1. M/s Abdur Rekib, North Bongaigaon, Rangia, Assam

(iv) Receiving of Bids: 1 (One) nos. of bids were received through online mode in the official e-tendering portal of <https://eprocure.gov.in/eprocure/app> till the deadline time i.e. 14.00 hours on 29.06.2026. Accordingly, as stipulated vide MoRT&H's circular no eFile No.RW/NH-33044/25/2024-S&R(P&B)(Computer No. 240989) dated 28th August, 2024 BEC(para 4) BEC decided to evaluate the single bid of the bidder, namely- M/s Abdur Rekib, North Bongaigaon, Rangia, Assam.

C. Evaluation of Technical Bids:

To establish the responsiveness of each & every individual technical bid, the qualification information submitted online by the bidder has been examined on the basis of technical qualification criteria laid down in the bidding documents and compiled in the form of a statement - "TABLE FOR EVALUATION OF SUBSTANTIVE RESPONSIVENESS OF TECHNICAL BIDS" to be placed before the Bid Evaluation Committee.
