

MINUTES OF FINANCIAL BID EVALUATION COMMITTEE MEETING HELD ON 14.07.2026 AT 15:00 PM
IN THE OFFICE OF THE REGIONAL OFFICE, MORT&H, ASSAM, CHANDMARI, GUWAHATI-03

Name of Work: "Urgent Restoration of waterlogged stretch at Km 16/620 (Abhaypur) of NH-427 with GSB, WMM and Interlocking Concrete Block Pavement under PWD, Guwahati NH Division in the State of Assam (Under Contingency Provision of Job No. 129/PBMC/AS/2024-25/272)"

Bid Value:Rs.18,46,846.00/- (Excluding GST & including 1% Labour cess)

Based on the recommendation of the Bid Evaluation Committee in the minutes of technical bid evaluation meeting held on 06.07.2026, the financial bids of following 1(one) technically responsive bidder were opened on 14.07.2026 at 15:00 PM in the O/o the Regional Officer, MoRT&H, Guwahati, in presence of the Bid Evaluation Committee (BEC) members. The summary of the financial bids opened is as follows:

The committee recommends that the work may be awarded to the bidder- **Abdur Rekib, North Bongaon, P.O. Rangia,P.S. Rangia, Kamrup - 781354**, at their lowest quoted bid price of **Rs.16,43,250.00 (Rupees Sixteen Lakh Forty Three Thousand Two Hundred and Fifty Only)** which is 11.02% below the amount put to tender Rs.18,46,846.00. In keeping with provision of clause 34.1 of Instructions to Bidders of the bidding document the BEC has recommended that the bidder must provide a performance security of 3 % (Three percent) of the amount quoted by the bidder i.e. 3% of Rs. 16,43,250.00= Rs. 49,298.00 (Rupees Forty Nine Thousand Two Hundred and Ninety Eight only). Additionally, the bidder is required to furnish an additional performance security along with the performance security of 3% (three percent). The calculation for the additional performance security for the unbalanced bid is determined as per Clause 34.2.1 of RFP which comes out to be 0.10% (Zero point One percent). Therefore, the additional performance security that shall be obtained from the L1 bidder is found to be 0.10% of bid price, which is Rs. 1643.00 (Rupees One Thousand Six Hundred and Forty Three only).

Since, it has become an instance of Single bid, the BEC has decided to check the conditions as per Ministry's Circular No. RW/NH-33044/25/2024-S&R (P&B) (Computer No. 240989) dated 28.08.2024 on "Acceptance of Single bid for National Highway works".

- i. The Procurement was satisfactorily advertised in central public procurement portal of MoRT&H website <https://eprocure.gov.in> and sufficient time of 21 days has been given for submission of bids in accordance with GFR Rule 161.
- ii. The qualification criteria were not unduly restrictive.
- iii. The third criteria which is regarding reasonability of prices is that the offered price of the bidder is 11.02% below the SOR which is found reasonable.

In view of the above, the Bid Evaluation Committee (BEC) decided that, the work shall be awarded to the L1 bidder subject to approval of the Additional Performance Security for the bidder from the Competent Authority in accordance with MoRT&H's latest circular no. RW/NH-33044/34/2024-S&R (P&B) (Computer no. 246283) dated 30.04.2025 and subsequent amendments

The item wise rates quoted by the technically responsive bidder considered for financial evaluation is depicted in the Comparative Statement attached herewith.
