Name of Work: Supply, Installation, Testing, Commissioning, Operation & Maintenance of Centralized Control & Monitoring System (CCMS) for Highway Lighting on National Highways under the Jurisdiction of National Highway Circle, Konkan Bhavan, Navi Mumbai, in the State of Maharashtra on Five (05) Year Contract Basis.

Bids are invited from experienced and reputed Contractors having proven experience (minimum of three years) in the supply, installation, testing, commissioning, operation and maintenance of **Centralized Control & Monitoring Systems (CCMS)** for highways, urban roads, municipal corporations, or other government infrastructure projects.

The Contractor who download the NIT documents from the website will be required to pay a non-refundable fee of **Rs.10,000/- (Rupees Ten Thousand only)** at the time of the submission of the Bid proposal.
 - The Bidders shall also submit Rs.11,800/- [Rs. Three Thousand Five Hundred Forty Only] towards the cost of tender [Tender fee Rs. 10,000/- [Rs. Ten Thousand Only] to be submitted through the portal “bharatkosh.gov.in” (scanned copy of receipt / document to be submitted online on eprocure.gov.in] + 18% GST amounting to Rs.1800/- Rs. One thousand eight hundred Only Contractor should have to pay applicable amount of GST @18% on tender document fee under head Reverse Charge Mechanism under GST act and Challan Receipt / Document in support of online payment to be submitted online on eprocure.gov.in)

The Bidders shall pay online and submit a payment receipt for **Rs. 10,000/- (Rupees Ten Thousand only)** towards cost of RFP at the time of the submission of the Bid proposal through Bharatkosh website <https://bharatkosh.gov.in> payable to Regional Pay and Accounts Officer PAO - 034650 - PAO (NH), Mumbai MoRTH, DDO Code- 234652 S.E., PAO Code-002193. Proof of fee submission shall be submitted along with the technical proposal.

Guidelines for depositing tender fee online through Bharatkosh portal

1. Tender fee shall be deposited **ONLY** online through the NTRP portal (Non-tax receipt payment) of the Government of India (bharatkosh.gov.in)
2. Tender fee paid through any other mode shall not be accepted and any such bid shall be summarily rejected.
3. The GST amount on tender fee shall be paid through a demand draft in favour of the concerned Executive Engineer.
4. The steps to be followed for online payment of tender fee –
 - (i) Visit www.bharatkosh.gov.in
 - (ii) Click on Non-Registered Users
 - (iii) On the next page – fill the following details:
 - (a) Depositor's category – Individual / Corporates as applicable
 - (b) Click on the search icon in "PURPOSE"
 - (c) In the page that follows –
 - (i) Select – Road Transport & Highways for Ministry
 - (ii) Then click on "SEARCH" button in the bottom of the page
 - (iii) In the page that follows – for selecting "PURPOSE", look for and click on "Sale of Tender Documents" on page 2 of the list.
 - (iv) Fill of rest of the form as follows –
 - (a) Pay & Account Office (PAO) – 034650 – PAO(NH), Mumbai
 - (b) Drawing & Disbursing Office (DDO) – 234652 – S.E.
 - (c) Amount – Rs. 20000
 - (d) Remarks – Name of the Project & Name of NH Division
 - (v) Click on "ADD" (vi) On the next page, after verifying details, click on "NEXT".
 - (vii) On the next page, fill up Bidder details, and mode of payment – Either "ONLINE" or "SWIFT/NEFT/RTGS" as applicable.
 - (viii) Click on "NEXT" to make payment & enter payment details.
 - (ix) Save a copy of the payment receipt to enclose with bid.

The RFP will be invited through e-tendering portal of **official portal of the CPPP website <https://eprocure.gov.in>** only. Refer procedure under e-tendering for submission of RFP through e-tendering.
