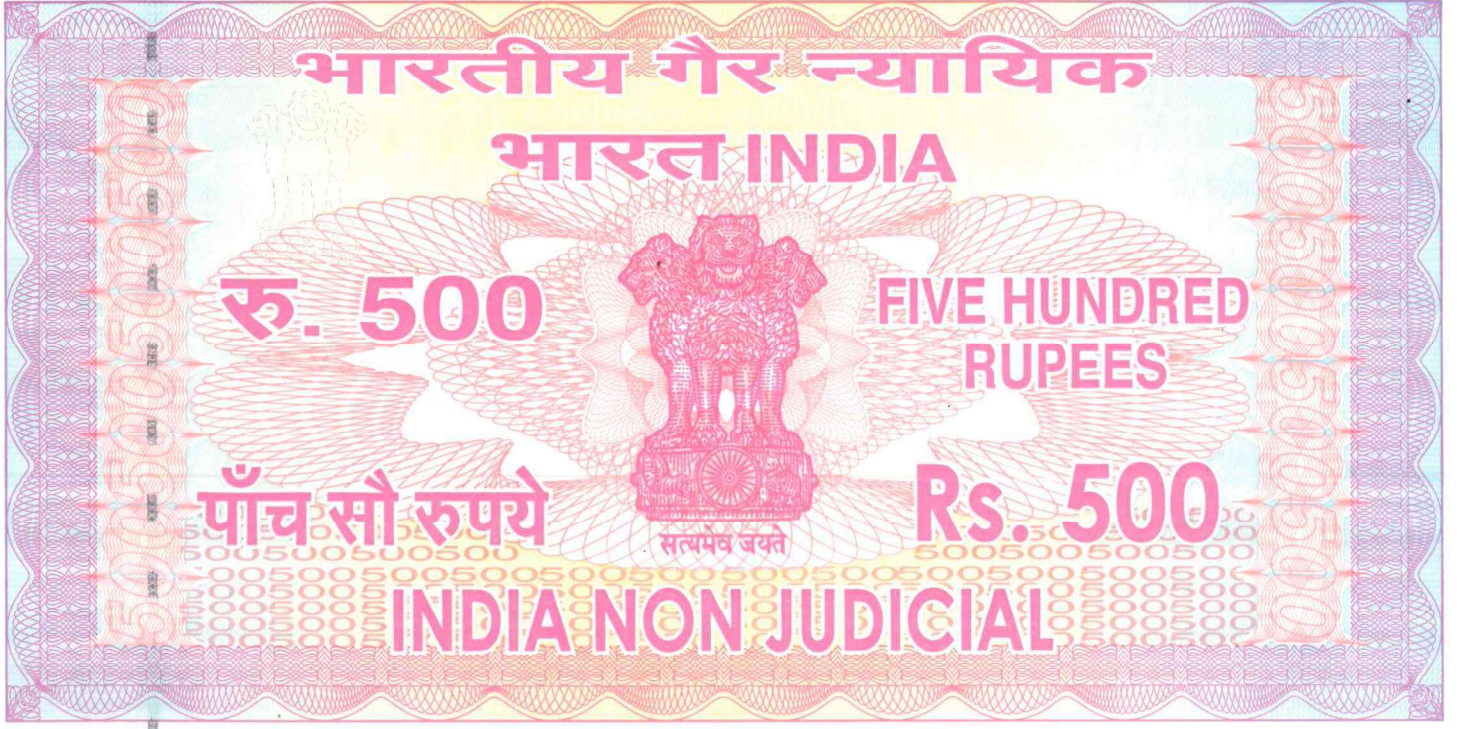

- (C) The Authority accordingly invited the proposals (the “Request for Proposal” or “RFP”) from the eligible bidders as per the technical and commercial terms and conditions prescribed in the RFP for undertaking the Project.
- (D) After evaluation of the bids received, the Authority accepted the bid of the selected bidder and issued its Letter of Acceptance No.NHAI/11015/565/RO Chennai/E-296212/617, dated 09.03.2026 (hereinafter called the “LOA”) to the selected bidder for Permanent Rectification of (i).Black spot ID : TN-(05)-037 at km 126+000 (Tindivanam Outer Junction) by Construction of VUP (2x12x5.5m), (ii).Black spot ID : TN-(02)-175 at Km. 137+840 (Cendur Junction) by Construction of VUP (1x12x5.5m), (iii).Black spot ID: TN-(05)-040 at Km. 139+840 (Palapattu Junction) by Construction of LVUP (1x12x4.5m) and (iv).Black spot ID: TN-(02)-169 at km 159+870 to 160+595 by Construction of Service road on RHS in the Tindivanam to Ulundurpet section of NH-32,132,38 (Old No. NH-45) in the State of Tamil Nadu on EPC mode at the Contract Price of Rs. 62,77,00,000/- (Rupees Sixty Two Crores Seventy Seven Lakhs Only) excluding GST, requiring the selected bidder to inter alia:
- (i) to give his consent to enter into this Agreement and the enforceability of the provisions thereof, within 10 (ten) days of the date of issue of LOA;
 - (ii) submit Performance Security and Additional Performance Security (if any) as per RFP requirements, and
- (E) The Contractor has furnished Performance Security and Additional Performance Security in the form of Insurance Surety Bonds on 28.04.2026, (i) ISB No.1342, dated 21.04.2026 for an amount of Rs.1,88,31,000/- (Rupees One Crore Eighty Eight Lakhs Thirty One Thousand Only) towards Performance Security, (ii) ISB No.1343, dated 21.04.2026 for an amount of Rs.2,87,00,000/- (Rupees Two Crore Eighty Seven Lakhs Only) towards Additional Performance Security.

NOW, THEREFORE, in consideration of the foregoing and the respective covenants set forth in this Agreement, the sufficiency and adequacy of which is hereby acknowledged, the Authority hereby covenants to pay the Contractor, in consideration of the obligations specified herein, the Contract Price or such other sum as may become payable under the provisions of the Agreement at the times and in the manner specified by the Agreement and intending to be legally bound hereby, the Parties agree as follows:

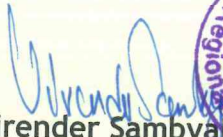
