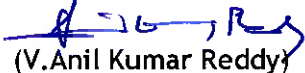

Shree Sai Industries	Technically Non - Responsive As per Clause 5.4.1 (a) Even if a bidder meets the above criteria, he shall be subject to disqualification if he or any of the constituent partners is found to have: (a) made misleading or false representations in the forms, statements and attachments submitted and included in the application; or During scrutiny of the bid documents, it is observed that in Form-2 (General Construction Record Form), the bidder's name is mentioned as "Lord's Mark Industries Pvt. Ltd.". This discrepancy appears misleading regarding the submitted documentation.
