Further, UDIN has not mentioned in submitted Financial Statement for Financial Year 2024-25. Therefore, submitted Financial Statement for FY 2024-25 has not been considered. Thus, the bidder has not fulfilled the Net Worth. Based on the above facts, the bidder has been considered as non-Eligible as per clause 3.3 A (a) & 3.3 (A) (b) of RFQ.
