S. No.	Name of the bidder	Remarks
1	M/s Gayatri Construction Co.	The bidder failed to meet the eligibility criteria as per Clause 4 of 'Invitation for Bids (IFB)' as the digital signatory does not match the Power of Attorney. Further, bidder does not meet the requirements of clause 1.3.1 (b) of Section IX regarding particular construction experience, and 1.6 of Section IX of RFP regarding financial capacity. Accordingly, the bid of M/s Gayatri Construction Co. is declared as Non-Responsive as per Clause 4 of 'Invitation for Bids (IFB)', clause 1.3.1 (b), and 1.6 of Section IX of RFP

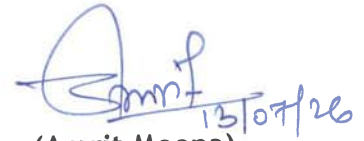
