Minutes of Evaluation Committee meeting held on 24.07.2026 at O/o Regional Officer, Vijayawada for Technical Evaluation & Intimation of Opening of Financial Bids of the work "Construction of Service Road works of Flyover at Km.936+440 (Jonnada Junction), Flyover at Km.967+180 (Undrajavaram Junction) and Flyover at Km.910+760 (Morampudi Junction) in the section of NH-216A in the State of Andhra Pradesh on item rate (percentage) basis" (Tender ID: 2026_NHA1_281570_1)

The Evaluation Committee met on 21.07.2026 and decided to obtain confirmation for receipt of tender fee and Bid Security submitted by the bidders from F&A unit, RO, Vijayawada.

2.1 Accordingly, vide Office Note dated 21.07.2026, F&A Unit has been requested to verify & confirm the said transactions in NHA1, RO - Vijayawada account, for taking further necessary action.

2.2 In-reply, F&A Unit, RO, Vijayawada vide Note # 24.07.2026 has confirmed the requisite Tender Fee & Bid Security submitted.

2.3 The Technical Evaluation Committee met on 24.07.2026 and carried out the detailed Technical Evaluation of the bids and made the following deliberations.

(i) M/s. Sudharma Infratech Pvt. Ltd:

As per Clause 4 of Section - I - Procedure under E - Tendering & Instructions to Bidders, "A Bidder is required to submit, along with its technical BID, a self - certification that the item offered meets the local content requirement for 'Class - I Local Supplier' / 'Class - II Local Supplier', as the case may be. The self - certification shall also have details of the location (s) at which the local value addition is made. In case, bidder has not submitted the aforesaid certification the bidder will be treated as 'Non - Local Supplier'.....

In case of procurement for a value in excess of Rs.10 Crores, the 'Class - I Local Supplier' / 'Class - II Local Supplier' shall provide a certificate from the Statutory Auditor or cost auditor of the company (in case of companies) or from a practicing cost accountant or practicing chartered accountant (in respect of suppliers other than companies) giving the percentage of local content.

However, it is observed that the bidder has not confirmed any percentage of Local Content in the Self Certification instead informed that they are purchasing all the materials from local market only.

Further, as the procurement value of subject tender is Rs.6,72,78,767/- which is less than Rs.10 Crores certificate from the Statutory Auditor or cost auditor is not mandatory.

As per Clause 13.1 (iv) of Section - I - Procedure under E - Tendering & Instructions to Bidders, the bidder shall submit "Form of Bid and Appendix to Bid" duly filled in and signed by Authorised Signatory on each page. However, on verification it has been observed that the bidder has submitted & duly signed only Form of Bid but not the Appendix to Bid.

(ii) M/s. Vijayalakshmi Projects LLP:

As per Clause 4 of Section - I - Procedure under E - Tendering & Instructions to Bidders, "A Bidder is required to submit, along with its technical BID, a self - certification that the item offered meets the local content requirement for 'Class - I Local Supplier' / 'Class - II Local Supplier', as the case may be. The self - certification shall also have details of the location (s) at which the local value addition is made. In case, bidder has not submitted the aforesaid certification the bidder will be treated as 'Non - Local Supplier'.....

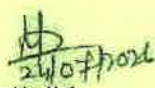

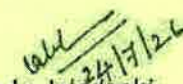
- (i) To consider both the bidders as **TECHNICALLY RESPONSIVE** & eligible for opening of Financial Bids.

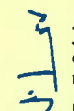

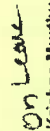

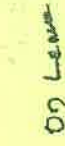
