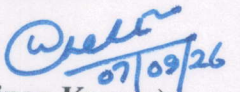

It was observed that the Bidder had submitted only 19 pages of documents along with the original bid submission. Subsequently, during the clarification stage, the Bidder submitted additional documents/certificates which were not part of the original bid submission. In this regard, as per Clause 23.4 of Section-II of the RFP, submission of additional documents during clarification, which has the effect of supplementing the bid, is not permissible. Accordingly, the additional documents submitted by the Bidder during clarification cannot be taken into consideration for evaluation of the bid.

Further, the Bidder has submitted certain certificates in support of compliance with the requirement of similar completed works. However, the certificates submitted are not in accordance with the requirements stipulated under Clause 4.4(A)(b) of Section-II and Clause 1.4(a) of Section-III of the RFP. The certificates submitted in support of the similar work experience have been issued by private firms/entities, and no certificate issued by the Government Department/Authority/competent Government agency, as required under the aforesaid provisions of the RFP, has been found in the original bid submission.

In view of the above, the Bidder has failed to establish compliance with the requisite eligibility/experience criteria as stipulated in the RFP. Moreover, the additional documents furnished subsequently during clarification cannot be considered in terms of Clause 23.4 of Section-II of the RFP.

M/s Godara Construction Company

The Bidder has submitted only one certificate pertaining to Internal Road (HSVP), placed at PDF Page No. 22 of the bid. No other certificate in support of the requisite similar work experience, as required under the RFP, has been found in the original bid submission.

During clarification, the Bidder has stated that the work certificate submitted pertains to NH-22. However, on examination of the certificate issued by HSVP, it is observed that the title of the work is:

“Construction of H.L. Bridge on Kaushalya River and 45m wide Periphery Road from NH-22 (Now NH-05) to Circular Road of Sector 3, 4 and 5, Pinjore Kalka Urban Complex, Panchkula in Haryana on EPC Mode.”

The Committee noted that, as per the description of the work in the certificate itself, the 45 m wide Periphery Road is a connecting road from NH-22 (now NH-05) to the Circular Road of Sector 3, 4 and 5, Pinjore Kalka Urban Complex, Panchkula, and the certificate does not establish execution of the requisite work on NH-22/NH-05.

Accordingly, the said certificate cannot be considered for meeting the requirement of similar work under Clause 4.4(A)(b) of Section-II of the RFP.

In view of the above, the Bidder has failed to establish compliance with the requisite similar work experience criteria stipulated in the RFP.
