Dear Sir/ Ma'am,

With reference to above, Oil and Natural Gas Corporation Ltd (hereinafter referred to as ‘ONGC’/ ‘CORPORATION’/ Company-Hazira Plant) is pleased to place this Notification of Award (NOA) to M/s UNITED & SOCIAL ENGINEERING (hereinafter referred to as “Contractor”) for “FABRICATION, SUPPLY AND INSTALLATION OF MANHOLE COVERS FOR COLUMNS AND VESSELS AND NAMEPLATES FOR MARKING OF PWS, OWS, SWD and SCTP PITS OF GSU, GDU, DPD, LPG, KRU, NFU, CFU AND ATFPU” with following terms and conditions:

1.0 Scope of work:

The Scope of work/ specifications & other Terms & Conditions shall be as per the tender document including addendum(s), if any.

2.0 Completion Period/ Duration of Contract:

This work contract shall remain valid for a period of 120 Days from the date of placement of Notification of Award (NOA). (Mobilisation period of 10 Days is inclusive of the completion period.)

3.0 Schedule of rates:

The rates applicable for the works to be rendered under this contract shall be as per the Schedule of Rates enclosed at Annexure-I of this NOA and remain firm for the contract period.

4.0 Other terms and conditions:

All other terms & conditions of contract shall be as per subject tender to be read with clarifications/ amendments and subsequent correspondences, if any.

5.0 Security Deposit / Performance Security:

- 5.1 The contractor shall furnish Security Deposit/ Performance Security **within 30 days** from the date of issue of NOA i.e. **on or before 15.05.2026** for a sum equivalent to 10% of the contract value i.e. **Rs. 1,94,169.00/-** (Rupees One Lakh Ninety Four Thousand One Hundred Sixty Nine only) either in the form of NEFT/RTGS/Electronic fund transfer to the following designated account of ONGC#:

in lieu thereof an irrevocable Electronic Bank Guarantee(e-BG)/ SFMS Bank Guarantee (SFMS BG)/ Unconditional irrevocable Insurance Surety Bond as per the proforma enclosed in the General Condition of Contract (GCC) in the bidding document. The Performance Bank Guarantee will have 10% of the contract value i.e. **Rs. 1,94,169.00/-** with initial validity **till 11.11.2026**.

Claim period: Minimum One month beyond validity of PBG i.e. **on or after 11.12.2026**.

As per actual completion of contract, contractor will have to submit another Performance Bank Guarantee equivalent to **5% of the contract value** for the **warranty period of contract** i.e. **12 months from the date of final completion certificate issued from ONGC**. The initial validity of PBG submitted against the warranty period shall be warranty period of contract (after completion of work) + 90 days. Further, Claim period: Minimum One month beyond validity of PBG.

The default/Preferable mode of submission of Security Deposit will be NEFT/RTGS/Electronic fund transfer or e-BG, however, whenever a contractor submits an SFMS BG, they will mandatorily be required to submit a letter from the issuing bank that it is unable to issue a NeSL based e-BG as on date. Such letter should accompany the SFMS Bank Guarantee (SFMS-BG).

- 5.2 In case the contractor fails to submit the security deposit within the stipulated date, ONGC shall recover a sum equivalent to 1.5% (one and half percent) of the amount of Security Deposit / Performance Security per month for such delay or part thereof from the first Bill/invoice (& any remaining amount from subsequent invoice) submitted by the supplier/contractor.

6.0 Signing of Contract:

This NOA will constitute the formation of contract. The detailed formal contract shall be signed by both parties within 15 days from receipt of acceptable Security Deposit/ Performance Security. Accordingly, after submission of Security deposit, it is requested to depute authorized representative holding valid power of attorney for signing of detailed contract, under intimation to this office.

- 6.1 ONGC's obligation to make payments would start only after submission of Security Deposit / Performance Security and signing of detailed contract. Until the formal contract is signed, this NOA shall be binding contract between ONGC and the Contractor read along with the scope of work, technical specifications, special condition of contract and other terms and conditions of tender document.

- 6.2 Duration of Contract shall be firmed for signing of detailed contract. Accordingly, site handing over date shall be mutually agreed and signed by ONGC and contractor for signing of detailed contract.
- 7.0 For all matters related to execution of contract, please contact **Area Manager- Condensate Processing Group, ONGC Hazira Plant.**
- 8.0 You must confirm within 03 days of issue of NOA that Security Deposit shall be submitted within 30 days from the date of NOA. Non –submission of Security Deposit within stipulated period may lead to annulment of the contract and action against the contractor as per tender/NOA conditions.
