The tender for the “Repair of three nos. of Controllers” was invited to OES **M/s Panseis Geo Services Pvt. Ltd., Noida** through GePNIC. The Detail of the tender is as follows:

2.0 Bid Evaluation:

As per the analysis of bid, the compliance of the bidder with respect to Technical Scope of Repair, commercial BEC and important tender conditions is brought out here as below:

2.1 Compliance with Tender Conditions: The bidder has accepted all the term and Conditions of the contract as stipulated under tender document in annexure I,II & III and has submitted the requisite undertaking as per **Appendix-3** of the tender document. Accordingly, the bid submitted is **technically Acceptable**.

Based on the documents submitted and the undertakings furnished, the bidder is found to be **Commercially Acceptable**.

2.3 **Conclusion:** In view of the compliance brought out at Para 2.1 and Para 2.2, the offer of M/s Panseis Geo Services Pvt. Ltd., Noida (OES) is considered **Techno-Commercially Acceptable**.

3.0 Rate Reasonability:

3.1. The controller SGD- SP unit is integral & Critical part of Node Based Seismic data acquisition unit that were supplied by M/s Sercel, France under PO dated 4050014648. As per Commercial Invoice **89027410** (attached at Annexure no.6), the FOB Price of Controller SGD-SP per unit was \$ 2792.20. (Considering exchange rate 1 USD= 90 INR, the Price of Controller translates to INR 2,51,298.00). The **Country of Origin** of these controllers is **Russia**.

3.2 M/s Sercel vide mail dated 07.10.2025 informed that they don't have any spares of these controller due to European and international sanctions against Russia instead Sercel proposed a compatible independent shooting system costing **EUR 248,228.98** (FCA Charges). (Mail correspondence is attached at Annexure 7). M/s Panseis Geo Services Pvt. Ltd, Noida(OES) of these controllers in India have been contacted thereafter to carry out the repair of these controllers instead.

3.3 The Repair cost quoted for the controller quoted M/s Panseis Geo Services Pvt. Ltd is approx. 19.19 % of the Original equipment cost (2021 price escalated to current dollar conversion). Considering the price escalation of equipment approx. 5% per year the replacement comes to around 20%. Also, the original controller price quoted by Sercel was under an LSTK tender where pricing strategy differs significantly from stand-alone procurement.

3.4 The Repair of these items is undertaken for the first time, Hence No LPR Exists.

3.5 The bidder vide appendix 14 has submitted the best price undertaking that the prices quoted by them for the items/services of same specifications are not more than what we charge to other customers.

3.6 In view of above, considering the criticality of the item for the entire data acquisition unit and price quoted by the OES, the price can be considered reasonable.

4.0 Financial Implication:

4.1 Total financial implications worked out on the basis of price Quoted (Price bid is attached at Annexure no. 10) by the vendor for the Repair of Three nos. of controllers SGD_SP is reproduced as under :
