A. Background:

Ltd. (v/c 917674), authorized dealership certificate is attached in **Annexure-01**, for all the Generator sets of engine make M/s Cummins deployed under Surface Team & Well services for a period of 3 years. Corresponding purchase requisitions, PR no. 2090065958 (sanctioned amount, INR. 752,092.48, incl. GST) & PR no. 2090065855 (sanctioned amount, INR. 752,092.48, incl. GST) has been released at appropriate levels.

Single Tender OEM/OES basis was invited for OEM/OES service contract in a single bid system against PR no. 2090065958 & 2090065855 and RFQ was issued to M/s Garuda Power Pvt. Ltd. through GePNIC portal as per the SCM para no. 10.2.6 (ix) & 11.2.1-ii(1).

M/s Garuda Power Pvt. Ltd. has participated in the tender and submitted their bid along with other documents associated with the tender requirement, the same has been attached in **Annexure-6 & 7**.

B. Technical Comment:

In reference to **Annexure-6 & 7**, the bidder has submitted documents in-line with the technical requirement of the tender with no deviation. Hence, the bid may be considered as technically acceptable.

C. Comparative Statement:

The comparative statement has been prepared based on a comparison between the estimated/sanctioned rates—derived from an existing contract of similar nature of work and the rates quoted by the bidder. The details have been tabulated in **Table-A**.

The NOA issued by ONGC Assam Asset, which was considered as the Last Purchase Rate (LPR) while preparing the cost estimate and obtaining approval for the sanctioned amount, is attached as **Annexure-8**.

2. Techno-Commercial Evaluation:

Offer along with tender documents has been submitted in GePNIC portal by M/s Garuda Power Pvt. Ltd. and opened on consecutive date and the same is attached in **Annexure-6 & 7**.

2.1 Technical Evaluation

As per technical comments furnished and approved as provided on dated 24.02.2026, PEC opined that the offer of the bidder is technically acceptable.

2.2 Commercial Evaluation

PEC has gone through the tender documents submitted by the bidder and found the bid to be commercially acceptable.

2.3 Comparative Statement

PEC also noted “Comparative Statement” as prepared and which has been tabulated as below:

3. Rate Reasonability

A. Rate Reasonability:

In reference to SCM manual para 13.2.4.vii), which quote as below:

Quote:

In OEM / OES / nomination cases, reasonability of quoted prices will be ascertained with respect to LPR of ONGC / published price (if available)/LPR of any other company as provided by the bidder.

Unquote:

PEC has considered the existing contract (attached as **Annexure-8**) executed between ONGC, Assam Asset and M/s Garuda Power Private Limited as the Last Purchase Rate (LPR) based on “similar nature of work” for the purpose of ascertaining rate reasonability. The same contract was also relied upon while preparing the cost estimate during the sanctioning process.

4. PEC Observations & Deliberation :

After reviewing all the documents submitted by the bidder, referring to **Annexure- 6 & 7** of DISHA, following observations have been made by PEC:

- a. Sanction exists for a total amount of INR 15,04,184.96 against PR No. 2090065958 (sanctioned amount: INR 7,52,092.48 inclusive of GST) from Surface Team and PR No. 2090065855 (sanctioned amount: INR 7,52,092.48 inclusive of GST) from Well Services.
- b. The bids submitted by the bidders are in accordance with the technical specifications outlined in the tender document, as reflected in the technical comments.
- c. A Last Purchase Rate (LPR) exists with ONGC Assam Asset for a similar nature of work with the same bidder.
- d. PEC observed that the annual escalation on man-day rates in the LPR contract is 5%, excluding GST.

e. In the present tender, the bidder has quoted a yearly escalation rate of 10%, excluding GST, which is higher than the annual escalation rate stipulated in the existing LPR contract with the same bidder.

Based on the above observations, PEC deliberated that the offer submitted by M/s Garuda Power Pvt. Ltd. (Authorized Dealer) is in accordance with the technical specifications of the requirement. However, the offer may be subjected to price negotiation to ascertain rate reasonability, particularly in comparison with the existing LPR.

5. PEC recommendations:

In view of the above deliberations, the Procurement Evaluation Committee (PEC) recommends that *price negotiation* may be conducted with the bidder, i.e., M/s Garuda Power Pvt. Ltd., with prior approval of the L-1 Executive, in accordance with Para No. 13.2.9(i) of SCMM.

2. Price negotiation:

a. In the initial submitted bid, the bidder has quoted with a yearly escalation rate of 10%, excluding GST. However, in the LPR contract executed between ONGC, Assam Asset and M/s Garuda Power Private Limited as attached in Annexure-8, with 5% yearly escalation rate, excluding GST.

b. In reference to the above, a price negotiation with the bidder was recommended by the PEC members, which was approved by the L1 Executive as per Para 13.2.9(i) of SCMM, in order to align the yearly escalation rates with those of the existing contract considered as the LPR for similar nature of work.

c. After detailed discussions, the bidder agreed to match their yearly escalation rates (percentage) with existing contract rates between them and ONGC, Assam Asset.

d. Accordingly, the bidder has confirmed the negotiated rates through returned mail and has submitted their revised offer, as attached in **Annexure-9**.

3. PEC observation and deliberation:

After going through all the documents submitted, correspondence received from the bidder and discussions, following observations are made by PEC members:

a. The bid submitted by bidder is techno-commercially acceptable.

b. The bidder has matched the yearly escalation rates of 5% as per the existing contract between them & ONGC, Assam Asset, refer **Annexure- 8**, considered as LPR in this case. After price negotiation, the effective man-day rates in comparison to initial offer shall be as detailed below:

c. PEC also observed that based on the negotiated rate, total cost of the contract, post negotiation shall be INR. 13,60,638.56 for the entire duration of contract which is **10% lower** than the sanctioned value of INR.15,04,184.96. Detail calculations are provided as below:

In view of above, PEC opines to create new vendor code for the bidder, since the services shall be provided by bidder's Dhandbad branch.

4. PEC recommendations:

Based on the above deliberations, Procurement Evaluation Committee recommends as under:

- a. To place Order against Tender No. **W36SS26001** to OEM authorized dealer M/s Garuda Power Pvt. Ltd. for the work– ***“Need & On-Call Basis Service from OEM/OES/ OEM Authorized Dealer or service provider/ Packager for all the Generator sets of engine make M/s Cummins India Ltd. (M/s Cummins) for a period of 3 years”*** as per the submitted documents.

Recommendation at **Para 4**, as above, requires approval of CPA, which in this instant case is L-II Executive in terms of para 13.2.10 of SCMM to be read along with para 24.1(b) of BDP 2015.
